1.	Readers and vendors are responsible for all permits, including sales tax, required for your business. You must have a copy of your sales certificate, or email/letter from the Texas Comptroller's Office, available for review by regulatory authorities and the fair producer.
2.	Applications and fees will be accepted only if space is available. Space is not secured until both the application and fee has been received and approved. NOTE: Fair fills up quickly therefore space is not guaranteed.
3.	Booth Fees will not be refunded if reader/vendor cancels for any reason as we must still pay for the venue.
4.	Readers/vendors may not arrange for alternate readers/vendors to occupy their space. Only the Fair producer may authorize space for readers and vendors.
5.	Sharing or splitting of table spaces between multiple vendors/practitioners is strictly prohibited. Multiple vendors may operate in the same space, but they must purchase at least one space per person
6.	You must be ready to begin reading/vending by 10:45 am and your booth must remain in full operating condition until 5:00pm unless approved in advance by the Fair producer. You must leave the area free from trash and in a clean condition
7.	Parental consent is required for all readings/psychic services provided for clients under 18 years of age. Consent may be verbal, or in writing, but must be documented by the reader providing the services.
8.	Signs may not be set up in walkways. Signs and displays must be tabletops, table banners, or small easel type (unless placed against a wall) and may not obstruct the public's view of readers and vendors. Please check on the height of signs before purchase. Decisions on appropriateness and placement of signage will be made by the Fair producer.
9.	If electricity is needed, please bring your own extension cord. Only industrial-grade extension cords are permitted. Electricity is not guaranteed
10.	Smoking, candles, incense and burning oils are not permitted. Use of essential oils and aromatic products may be restricted if complaints are received
11.	You can NOT hang wall décor. The costs of repair for damage to venue fixtures, walls, floor coverings will be the responsibility of the practitioner causing the damage.
12.	You may feel free to submit requests for consideration or complaints to the Fair producer without concern of reprisal. To ensure a response to your concern, please submit all issues to the producer in writing.
13.	Room temperatures can vary. There are times that the rooms(s) might be warm or cold. Please bring appropriate attire to suit your needs. Do not take any concerns about room temperatures or table space to the hotel staff. All concerns or complaints must be provided to the Fair producer.
14.	Not responsible for loss, damage, nor thefts during any event(s) conducted by Heaven-Pathways-Earth, Sheryl Martin, Holiday Inn, or any of their associations or other companies
15.	Although the Fair will have paid advertisement you must help publicize the event on your website, email, and/or social media. This will help increase participation and grow your business.
16.	Booth sizes may vary. Most booth space includes table and chair/s. You are responsible for your own cover and setup.
17.	No food or drinks are allowed to be given or sold to clients. You may bring your own food and beverage from home but due to the Hotels food and beverage licensing we are unable to provide food or drink to clientele, Fair participants, or vendors. The hotel will have a small lunch menu available. You cannot purchase fast food or other food and beverage and bring into the room
18.	No CONFETTI or GLITTER ALLOWED.
19.	Space is not reserved until BOTH application and payment are received
20.	A reasonable/competitive fee must be charged for the services that you provide.
21.	Hand sanitizer must be provided to Fair Patrons.

IMPORTANT:

In the State of Texas individuals who are providing services at a festival, fair or expo are considered amusement/entertainment and are required to have a sales tax permit, even if they do not sell products. Individuals giving readings such as psychics, mediums, tarot card readers are required to have a sales tax permit. You can obtain this permit from the Texas Comptroller website and are required to have it with you at all festivals, fairs, and expos.

Psychic, Medium, and Tarot Readings: Are taxed and not exempt.

Exemptions:

Energy Healing Services: Practitioners can provide this service and it is not taxable. If they are also providing readings or selling products then the reading and products are taxable.

Life Coaching or Consulting Services: Consulting services and life coaching services that are the expertise or a professional opinion of the consultant or coach are not taxed. This must be a standalone service. **If they are also providing reading or selling products then the coaching, consulting, reading and products are all taxable.**

Massages and Reflexology: If the massage or reflexology is being performed by a registered license massage therapist the service is not taxable. If they are also providing readings or selling products then the reading and products are taxable, **however if they are not a licensed massage therapist the service is taxable.**

Reiki: Reiki practitioners can provide this service and it is not taxable. If they are also providing readings or selling products then the reading and products are taxable.
